

Fall Together, Jolly Holiday, & Thrills and Chills Getaway Weekend to Sioux Falls Sweepstakes Official Rules

The following sweepstakes is intended for viewing in the 50 United States and shall only be construed and evaluated according to United States law. No purchase necessary. Void where prohibited by law. Participation constitutes entrant's full agreement and acceptance to these rules.
